All qualified voters of the Seaford Union Free School District will receive an absentee ballot along with a postage-paid return envelope. Ballots must be received by the District Clerk by 5 p.m. on Tuesday, June 9.

VOTER REGISTRATION AND REQUIREMENTS

Any resident of the School District who is not already a registered voter and wishes to be a registered voter for this election may register with the Board of Elections by submitting an online application for

voter registration with the Department of Motor Vehicles at https:// dmv.ny.gov/more-info/electronic-voter-registration-application.

To vote, you must be 18 years of age or older, a U.S. citizen and a District resident for at least 30 days prior to the vote. You must be registered to vote with the Seaford School District or the Nassau County Board of Elections or have voted in a political or general election within the past four years.

In compliance with Section 203 of the Voting Rights Act of 1965, the United States Census Bureau has designated Nassau and Suffolk counties as "coverage jurisdictions" that must provide election information in BOTH English and Spanish.

Q. What is on the ballot?
A. The following propositions are on the ballot:
• Proposition 1 – 2020-2021 School Budget.

Q. What is the proposed budget? A. The proposed expenditure budget for the 2020-2021 school year is \$73,005,631. This represents a budget-to-budget increase of \$2,348,682, or 3.32%.

Q. What is the tax levy increase?

A. The tax levy is \$55,047,849, an increase of \$1,901,670, or 3.58%, which is within the allowable tax cap.

Q. If the tax levy increases, does that mean my

property taxes will go up?

A. Not necessarily. The tax levy does not raise everyone's property taxes by the same amount. It is possible that a homeowner's property taxes will be higher, or even lower, than the tax levy limit. The increase depends on the assessed valuation of the property, which the District does not control. For questions about your property's assessment, contact the Nassau County Assessor's office.

Q. What happens if the budget is not approved?
A. Executive Order No. 202.67 does not

specify the date for a budget revote should the budget fail. Without further guidance from the Governor's office, we are uncertain about the ability to schedule a revote or whether a contingency budget would be adopted by the Board of Education. A contingency budget for Seaford would force the Board and Administration to seek \$1,901,670 in cuts. The effect of this, along with the strong potential of state aid cuts that could be as high as 20%, would translate into drastic cuts to school programs including academic, extracurricular, athletic and staffing across the District as well as reduction in transportation services (late buses for Seaford District and private school students). The contingency budget would also prevent the District from purchasing any new equipment and would not allow for any increase to the tax levy.

BUDGET SUPPORTS STUDENTS, STAYS WITHIN ALLOWABLE TAX CAP

Dear Seaford Residents.

We hope this message finds you and your family doing well amid these trying times. As a community, we have accomplished many wonderful things over the past few months. Our first responders, health care workers and many others have willingly risked their own health and safety to keep essential services operating. These actions truly embody Seaford

This situation has presented many challenges, including the need to educate students remotely; however, our community-supported Personalized Digital Learning initiative has allowed for continuous instruction. A special thanks must be extended to all the parents and guardians who are collaborating with our teachers to support the education of our students. We understand balancing personal responsibilities with assisting your own children with their remote learning is not easy.

Student access to these personal learning devices would not have been possible without careful long-term planning and community-supported school budgets. Our administrative team began building the proposed 2020-2021 budget in October 2019 and presented it to the Board of Education prior to the pandemic. The Board reviewed the proposed budget anticipating another wonderful upcoming school year.

Unfortunately, when the New York State budget was passed in April, there was no increase to the District's Foundation Aid for 2020-2021, which was less funding than the previous projection from the state. Also disturbing is that our actual state aid for 2019-2020 was over \$420,000 less than the projected amount last year. These fluctuations are troublesome. Trying to project the state aid for next year is even more challenging. Governor Cuomo has stated publicly that the Director of the Budget has the authority to reduce school aid three times during the budget year. This is unprecedented and creates a real cause for concern due to the potential loss of millions of dollars in aid.

As you may recall, when we presented our budget last year, we had a tax cap limit of 4.04%, yet we asked the community to support a 2.98% tax levy increase. In terms of dollars, this represented more than \$540,000 that was not raised by our community and funds that are technically lost annually given the way the tax cap is calculated. Every year, we look to find efficiencies and reduce spending, and weigh and balance the needs for our students and programs with the burden placed on our taxpayers.

Given the vulnerability of state aid and the potential loss of millions of dollars, this year we are presenting a tax levy increase of 3.58%, which is within our allowable tax cap. With the overwhelming support of the community, Seaford students have excelled in all areas. The proposed budget will continue to maintain those opportunities for our students. In anticipation of the state aid reductions, we have already begun to identify projects that can be delayed to a future date without impacting the instructional programs for students.

The budget includes continuing our Personalized Digital Learning initiative, which will place more devices in students' hands. To optimize the functionality of our infrastructure, we are upgrading the wiring in all four schools with over \$1 million secured through the New York State Smart Schools Bond Act. To begin this work at the Seaford Harbor School, we need to simultaneously do an asbestos abatement and replace all of the ceiling tiles.

All registered voters will automatically receive a paper ballot with a postage-paid return envelope. Once again, thank you for your continuous support. Together we will maintain educational excellence for our children.


