Ms. Hurley stated that Regents and AP Review Academies would be reinstated at the HS. Spring Middle School Sports would also be reinstated.

Mr. Kass spoke about Board credibility and making decisions to add programs back in to give the students a full education. Mr. Kass also advised that the Board is committed to holding the "Town Hall" meetings he has spoken about in the past. Scheduling has been an issue up to this point but there will be one scheduled soon.

He also advised that a small committee of individuals with real estate backgrounds has been formed to explore our options relative to the Seaford Avenue School and the property. This committee has already met once and has another meeting scheduled.

Mr. DiBlasio addressed a rumor going around that the Board was only concerned with finances. He stated that good sound accounting practices are needed in order to move forward with a better education for children. Many things are being addressed right now and things that need to be corrected to abide by state laws are being corrected. Many of these things happen to be financial. The Board is concerned about finances because we care about our children and about their education.

Mr. Duffy reminded everyone about the school play this weekend. He also advised that he and Brian Conboy had cosigned a letter that was on the website as well as going home with each student. This letter concerned student internet use, particularly a website called "My Space".

Mr. Conboy thanked the Seaford Wellness Council for the monies donated for Rachel's Challenge. He also announced the 50th Anniversary for the Manor School to be held on Saturday, May 13, 2006.
